### Besluit

#### *Openbaar met uitzondering van persoonsgegevens*

Ik besluit de overige documenten openbaar te maken, met uitzondering van de persoonsgegevens die daarin staan. Op de inventarislijst staat bij deze documenten aangegeven dat de uitzonderingsgrond uit artikel 5.1, tweede lid, aanhef en onder e, van de Woo (aangeduid met de afkorting 5.1.2.e) is toegepast.

#### *Bedrijfs- en fabricagegegevens*

Document 1 bevat een opsomming van de onderdelen onder de zogenoemde Hub's. Op grond van artikel 5.1, eerste lid, aanhef en onder c, van de Woo mag ik geen informatie openbaar maken als het gaat om bedrijfs- en fabricagegegevens die in vertrouwen aan de overheid zijn medegedeeld. De vertrouwelijkheid van de informatie die aan de overheid is verstrekt, kan bijvoorbeeld blijken uit een expliciete verklaring. Het is ook mogelijk dat de vertrouwelijkheid door de verstrekker mocht worden aangenomen. Verstreker mocht gelet op aard en inhoud van de e-mailwisseling aannemen dat de verstrekte technische informatie vertrouwelijk zou blijven.

Het gaat hier om gegevens waaruit informatie kan worden afgelezen over de technische infrastructuur van het netwerk van de verstreker. Hij verzoekt desgevraagd ook om deze informatie *niet* openbaar te maken.

De informatie waar u om heeft gevraagd gaat over de technische infrastructuur van het netwerk van de provider. Uit die informatie die aan mij is medegedeeld in het kader van het opstellen van eerder genoemde Kamerbrief (Kamerstuk 35 925 III, nr. 33), kan worden afgeleid op welke wijze betrokkenen zijn netwerk heeft ingericht. Ik zal deze informatie daarom niet openbaar maken.

#### *Het voorkomen van onevenredige benadeling*

Document 28 bevat een inlognaam en een wachtwoord. Op grond van artikel 5.1, vijfde lid, van de Woo mag ik in uitzonderlijke gevallen geen informatie openbaar maken als dit iemand onevenredige benadeling toebrengt en de voorkoming daarvan zwaarder weegt dan het belang van openbaarheid. Bij deze informatie. Deze benadeling bestaat uit het algemeen bekend worden van toegangsinfo. Ik vind dat de voorkoming van deze benadeling zwaarder moet wegen dan het belang van openbaarheid aangezien het beveiligen van apparaten en netwerken anders moeilijker wordt. Ik maak deze informatie daarom niet openbaar.



DAVOS (ANP/RTR/AFP) - De organisatoren van het World Economic Forum (WEF) hebben een nieuwe datum vastgesteld voor de internationale top. Die wordt nu van 22 tot 26 mei gehouden in het Zwitserse skidorp Davos, als dat tegen die tijd veilig kan.

De afgelopen twee jaar zijn de bijeenkomsten via internet gehouden vanwege de coronapandemie. Het WEF stond aanvankelijk wel gepland voor deze maand, maar eind december werd bekend dat de top opnieuw zou worden uitgesteld vanwege corona.

Doorgaans komen regeringsleiders en andere politici, maar ook topbestuurders uit het bedrijfsleven aan het begin van het jaar in Davos bijeen om te bespreken wat de wereld nodig heeft. Bij de komende top wordt onder meer gesproken over het herstel van de coronacrisis en de aanpak van klimaatverandering.

Het evenement vond al decennia vrijwel ieder jaar plaats in Davos. Het Zwitserse skioord werd iedere winter een week overgenomen door de mondiale politieke en bedrijfselite. Alleen in 2002, in de nasleep van de terroristische aanslagen in New York, verhuisde de bijeenkomst uit solidariteit voor een keer naar die Amerikaanse miljoenenstad.



Thank you for your email.

As promised, please find here enclosed the framework agenda for the Prime Minister.

We have delayed our programme release to later this months, after our Board of Trustee meeting, to ensure we reflect the latest geopolitical developments. Hence our programme is not yet final and changes could still occur. I have tried to reflect some key elements for the agenda of the Prime Minister. The Tuesday panel – which is the high level panel where we aim to invite other Prime Ministers of Europe – is scheduled for the moment on Tuesday morning. While the timing could still change, I wonder about what flexibility the Prime Minister has in travelling already on Monday evening? Or if he is set to be in Davos only on Tuesday afternoon as per 5.1.2.e previous email? Based on that we will work with our programme team and ensure that the Prime Minister can participate to a high-level panel on the topic of Europe's unity.

Another key element is the meeting with private sector on the CEO Action Group for the European Green Deal, where we wish to have the Prime Minister as special guest. This would be a private session that will allow a lively interaction with more than 50 business CEOs part of the community.

As you can see from the other elements, they are still preliminary and this is because we have delayed a bit our programme release.

I hope this framework agenda could support you in your discussion with the Prime Minister office tomorrow.

Some key points:

- Water related risks remain among the most pervasive, and stubborn challenges of our time (as reflected in the WEF Global Risk Report)
- The facts continue to be grim – where over a quarter of the global population – 2 billion people – use unsafe drinking water sources. Over 80% of wastewater is released to the environment untreated. Almost three quarters of all recent disasters are water-related, having caused economic damage of almost US\$700 billion in the past 20 years.
- COVID put the spotlight on the vulnerabilities of our global water systems – not only in terms of the importance of safe water access and hand hygiene, but also the fragility of our global supply chains
- Where water is traditionally considered a local issue, is now undeniably a global issue
- At the same time, following the global effort to tackle COVID and recent geopolitical conflicts in the world, it may be an understatement to say the conditions in which governments and business alike are operating are challenging. Resources and energy have been depleted, yet so many economic, social, and environmental priorities remain top of mind – if not even more urgent. Climate change, nature, social justice, health and wellbeing of populations. The list goes on.
- The natural instinct is to try and prioritize – which one to tackle first? Which is more important?
- There is an opportunity however for water to be the enabler and impact multiplier across multiple agendas and helping us to realize a transition to a green economy and net-zero / decarbonized industries
- To achieve this, there is an urgency for renewed energy, new multistakeholder approaches and innovation, and wider engagement and champions of other sectors in the agenda to position water as an enabler and impact multiplier across economic, social, and environmental agendas
- A powerful opportunity exists in 2023 with the UN Water Conference – the first in 44 years – and we can not shy away from this
- In this session, we'll explore these important links that water has across key efforts like climate change, and surface some interesting ideas looking forward

*Prime Minister, we've heard some examples of initiatives and ideas. What might you encourage or challenge these water champions to consider as they continue thinking and developing these ideas?*

Prime Minister to touch on:

- This is a great start. Welcome these kinds of ideas and thinking
- Let's certainly build on what we know, existing initiatives
- But we also need even more ideas brought to the Conference. And we need even more champions – from industry yes, but also governments, civil society, entrepreneurs, youth and more

- However, the effects of sanctions are starting to be felt—strong inflationary pressure is being felt on the continent and resulting political pressure is mounting in some countries.
- At the same time, the possibility of a NATO expansion is creating some frictions.
- Can Europe remain united and how can Europe promote more effective cooperation with partners, particularly in Africa, Asia, and the Middle East?

### Discussion (40 min)

The Moderator will engage the Panellists in a lively conversation to get their perspectives on the guiding questions or points as outlined below. The Moderator will then build on the introductory round of conversation by asking questions to create a dynamic flow of interaction among the Panellists.

Guiding questions may include:

- **Prime Minister Rutte**, you said in March that "it's time to build a stronger, more resilient Europe", one where "the EU must be a global player". Is this a turning point for Europe's global role, or more of a flash in the pan that may soon pass?  
141 countries voted to condemn Russia at the UN General Assembly, but many countries in Africa and Asia abstained from voting. Most of the material support for Ukraine is coming from Western powers. Many nations it seems don't really want to choose sides. What does this mean for Europe's geopolitical role in the world?
- 5.1.2.e you were elected President of the European Parliament only weeks before the war in Ukraine broke out, and your clear stance in response has been a defining feature of your presidency thus far. With the last European enlargement now almost 10 years ago [Croatia, 2013], what are the prospects for EU expansion? Are different levels of integration in an "à la carte Europe" the future of the European project? And can a growing Europe remain united, or will expansion create new friction points among members?
  - Additional context on other speakers: 5.1.2.e at the European Youth Parliament in mid-April said, "The people of Ukraine see their future in the European Union, and I very much welcome and support their application for membership."
- 5.1.2.e Ireland enjoyed a €4.5bn trade relationship with Russia before the war broke out. Other European countries also held strong economic ties with Russia. What do you believe is the outlook for the EU's relationship with Russia? Economically, geopolitically? Are we looking at the return of an iron curtain across Europe?
- 5.1.2.e : The sanctions imposed on Russia are adding to strong global inflationary headwinds. In many countries in Europe the price of fuel and important commodities are spiking. Already, we are seeing rising domestic political pushback. Does this political pressure risk threatening Europe's united stand? What can leaders do to address the economic challenges in their own countries as they look to maintain a united sanctions regime against Russia?
- 5.1.2.e , In the past, Slovakia has imported over 80% of its oil supply from Russia. What are your country's longer-term plans to diversify its energy sources and what concrete solidarity do you expect to receive from other EU member states and EU institutions to support this sudden transition?
- **Prime Minister Rutte**, European states, including the Netherlands, have militarily supported Ukraine in defending itself against Russian aggression. Is the EU set to hold a stronger defence and security role?
  - Neutrality and non-alignment have been a long-standing principle for some EU member states like Ireland, Austria, Finland and Sweden, affecting consensus on EU security policy.
- 5.1.2.e , you mentioned in early May during your State of the Union 2022 that "Europe may not be perfect [...] but it represents a bastion of liberal democracy, of personal freedoms, of liberty of thought, of safety and security." How can the EU approach divergence among its member states, particularly when it comes to the rule of law, judicial independence, and freedom of the press?
  - Rutte has also had strong words on Hungary and Poland undermining the rule of law and suppressing the free media last year.
- 5.1.2.e Asia is Ireland's third major export market, quite far after Europe and the US. This is also reflected in trade numbers from other Member States. How can Europe play a stronger role as a trading partner and source of investments in emerging and developing markets? (e.g. through the EU's Global Gateway strategy, the EU's response to China's BRI)

- 5.1.2.e : What economic role will a more unified Europe play in finding solutions to some of the world's biggest common challenges (e.g. climate change, health crises) and holding a stronger role on the global stage?
- 5.1.2.e , you welcomed 5.1.2.e earlier this month to discuss the situation in Ukraine and the work your country is doing to assist refugees from the war. Similar visits from US officials have been taking place regularly across the continent. How important a role does the transatlantic alliance still hold in Europe?

# Manifesto on Implementing the European Green Deal in the New Global Context

CEO ACTION GROUP FOR THE EUROPEAN GREEN DEAL

## 1. Our Vision

The members\* of the CEO Action Group for the European Green Deal reinforce their commitment to accelerate Europe's green transition and stand ready to support European governments in shaping policies that are "fit for purpose".

With the European Green Deal, the European Union has set a more ambitious path and is shaping policies that are accelerating Europe's transition into a resource efficient, sustainable, green, innovative, and digitally enabled economy. At the same time, the current spike in gas prices – 300% compared to year ago – is raising concerns over Europe's ability to meet its climate neutrality targets.

In this rapidly evolving global context, members of the Forum's CEO Action Group for the European Green Deal will raise their commitments to support the ambition of the European Green Deal and are ready to work together with policy-makers to transform Europe into a greener continent by turning the acute energy needs and global food security risks into economic opportunities.

Reiterating its support to achieve a 55% emission reduction by 2030, the private sector calls for stepped up collaboration between public and private sectors across three focus areas—energy, agriculture and food systems—as well as across four enablers touching upon innovation ecosystems, job markets, sustainability standards and financing crucial to bring about a just green transition.

**2. Strengthening Europe's innovation ecosystems**  
From R&D to final stage commercialization, the EU has fostered a comprehensive regulatory framework. At the same time, fragmentation across member states might hinder in some areas the ability for businesses to innovate at a large scale. Fostering harmonised policies that are evidence and science based, while further promoting early-stage innovation, will enable a significant upscale of climate technology. This could also have positive ripple effects across economic sectors.

The CEO Action Group commits to working together with national and regional policy-makers to shift policy makers away from the fossil-fuel paradigm to a new one without vested

interests and without compromising the EU's high health and safety standard. The CEO Action Group will also work with the Forum's community of Global Innovators to transform Europe into a global hub for innovation.

## 3. Preparing Europe's job market for the green transition

Europe's green and digital transition is set to shape the European employment landscape, concomitantly bringing along new opportunities and disrupting current jobs. Ensuring Europe's twin transition in a just and inclusive manner requires a stepping up of efforts from both the private and public sectors.

The CEO Action Group will conduct a dedicated survey to understand the needs and opportunities stemming from changing industry requirements and will coordinate the launch of action-oriented pilots under the framework of the European Skills accelerator.

## 4. Strengthening policy dialogue with global actors on sustainability standards

The EU's sustainable finance framework hinges on the bloc's green taxonomy, which will drive climate-positive, long-term investments. To this effect, ensuring comparability and harmonization between the EU framework and global standards is key.

CEO ACTION GROUP FOR THE EUROPEAN GREEN DEAL

## 1. Our Vision

The members\* of the CEO Action Group for the European Green Deal reinforce their commitment to accelerate Europe's green transition and stand ready to support European governments in shaping policies that are "fit for purpose".

With the European Green Deal, the European Union has set a more ambitious path and is shaping policies that are accelerating Europe's transition into a resource efficient, sustainable, green, innovative, and digitally enabled economy. At the same time, the current spike in gas prices – 300% compared to year ago – is raising concerns over Europe's ability to meet its climate neutrality targets.

In this rapidly evolving global context, members of the Forum's CEO Action Group for the European Green Deal will raise their commitments to support the ambition of the European Green Deal and are ready to work together with policy-makers to transform Europe into a greener continent by turning the acute energy needs and global food security risks into economic opportunities.

Reiterating its support to achieve a 55% emission reduction by 2030, the private sector calls for stepped up collaboration between public and private sectors across three focus areas—energy, agriculture and food systems—as well as across four enablers touching upon innovation ecosystems, job markets, sustainability standards and financing crucial to bring about a just green transition.




## As EU Seeks to Cut Fossil Fuel Ties with Russia, CEOs Step Up with Action Plan on Energy and Food Security

**Davos-Klosters, Switzerland, 24 May 2022** – The Russian invasion of Ukraine has exposed Europe's energy insecurity, threatening to reverse decades of progress away from fossil fuels and toward renewables. To meet carbon neutrality goals in the face of this challenge, and to address vulnerabilities resulting from dependence on Russian hydrocarbons, the World Economic Forum has convened business and public-sector leaders who have jointly committed to a redoubling of efforts to continue Europe's clean energy transition.

Today, the CEO Action Group for the European Green Deal published its Manifesto on Implementing the European Green Deal in the New Global Context. The CEO Action Group, representing 50 European companies with a combined annual turnover of 1.4 trillion euros, renewed its commitment to a 55% emissions reduction target by 2030. The group said it will focus its efforts not only on energy but on food systems as well — the insecurity of which was also laid bare in after the invasion of Ukraine on February 24. The manifesto specifies four drivers crucial to achieving this green transformation: innovation ecosystems, job markets, sustainability standards, and financing. It calls for closer collaboration with national and regional policymakers to facilitate that transformation.

Mark Rutte, Prime Minister of the Netherlands, identified expansion of renewable energy as the key to achieving genuine strategic autonomy for the EU. "Reducing unwanted strategic dependencies is needed to strengthen the EU's open strategic autonomy. Renewables give us the freedom to choose an energy source that is clean, cheap, reliable and ours. To make our own energy is the best answer. To do more in offshore wind, in solar power, in hydrogen, in biomethane."

European Central Bank President Christine Lagarde emphasized the crucial role the private sector must play. "The transition to net zero can only succeed if the private sector contributes decisively," said Lagarde. "It is important that business and industry leaders live up to the commitments of the European Green Deal."

"The European Union is determined to end our dependence on Russian fossil fuels as quickly as possible. We need to boost investment in the technologies of the future and stop funding Putin's war machine," warned European Commission Executive Vice President Frans Timmermans. "Renewables are the answer. By ramping up the rollout of solar, wind, biomethane, and renewable hydrogen, the RePowerEU plan greatly accelerates Europe's transition to climate neutrality."

"The current global geopolitical landscape has marked a turning point for Europe. Energy security has enhanced the need to meet climate goals on an accelerated timeline, therefore the CEO Action Group for the EU Green Deal will be key in setting the trajectory for European Union's green transition. Today's Manifesto marks a new beginning for the community, one that is already built on strong foundation, to further scale action and jointly achieve Europe's climate ambitions" said Børge Brende, President of the World Economic Forum.

"Europe has a unique opportunity to make itself greener, healthier and more sustainable to the benefit of all Europeans. Companies and CEOs will support this journey, which will make Europe more competitive while striving for inclusive growth." said Feike Sybesma, Chairman of the Supervisory Board of Royal Phillips and Ester Baiget, Chief Executive Officer, Novozymes.
